Name. The Trust shall be known by the name of GR (Ganga RamSingh) Charitable Trust.


Office The Registered office of the Trust has been and shall be at Gopalpura, Naya Bas Road Shamshabad Agra, in the State of UP.

Date of Commencement. The date of commencement of the Trust is 03.03.2018.

Aims and Objects. Aims and objects of the Charitable Trust shall be as follows:

- (i) To set up, run and administer an educational institution including medical college, research institute for the advancement and propagation of education and research.
- (ii) To manage, administer, own and to carry on the work of running hospital, clinics, dispensaries, maternity homes, rest house, child welfare and family welfare and family planning centers and also to carry on the work of running crèches.
- (iii) To establish, provide, maintain and conduct or otherwise subsidies research laboratories and experimental workshop for scientific and technical research and to undertake and carry on with all scientific and technical researches, experiments and tests of all kinds and to promote studies and research both scientific and technical, investigations and inventions by endowing or assisting laboratories, workshops, lecturers, meeting and conferences and generally to encourage, promote and reward studies, researches, investigations, experiments, test and invention of any kind in the field of medical service.





- (iv) Trustee. Any person makes, provides, collects, arranges or motivates for donation to the trust of Rs. 1 Lac (Rs. One Lac only) and above and has himself donated a minimum of Rs. 1 Lac(Rs. one Lac only) has rendered remarkable useful services to the Trust may become Trustee. - 7.7 The trustees shall be respectively chargeable only for such moneys, funds, securities and other assets of the Trust as they shall actually receive notwithstanding their signing any receipt for the sake of conformity and shall be answerable and accountable only for their own respective acts, receipts, neglects and willful defaults and not for those of each other, not for those on any bankers, brokers or other persons in whose hands any trust moneys or assets may be placed, deposited or come, not for the deficiency of any funds and securities, not for any other loss unless the same shall happen due to or through their or his/her own willful default or dishonesty respectively and in particular no trustee shall be bound to take any steps or proceedings against a co-trustee for any breach or alleged breach of trust committed by co-trustee.
- 7.8 Where the trustees in the purported exercise of the trust discretion and powers hereby or by low conferred, act on the advice of any counsel, solicitor or other lawyer, engineer, surveyor or land or estate agent, broker, cashier, accountant or expert, the trustees shall not be responsible for any loss that may result from acting on such advice but the act or omission shall be deemed to be authorized and proper and the advice shall operate to protect the trustees in the like manner as if the act or omission had been directed or authorized under an order of court of competent jurisdiction.

The quorum necessary before the extra-ordinary general meeting can proceed to business shall be at-least 2/3rd of the Board of trustees out of which 2 should be founder trustee, present at the meeting. Want of quorum in the requisitioned extraordinary general meeting shall mean the cancellation or the meeting.

The governing council is authorized to take any decision to meet out the object of the Trust which includes formation of committees & sub-committees, delegation of authority, formation of rules & regulations & all other work which is directly or indirectly related to achieving the object of the trust.

- 8.5 Terms of Office. The first Governing Council shall be in office till the elected Governing Council will take over the charge. If for any unavoidable reasons the elections are postponed the first governing Council shall continue to be in office. Elections will be held once in three years.
- 9 Right, Power & Duties of Office Bearers.
 - (i) Chairman & Managing Trustee. The Chairman and in his absence, the Vice-Chairman shall preside over the meeting of the Governing Council. If all the above office bearers remain absent, the Governing Council may nominate any one of them to preside over such meeting.

Amendment in Deed should be supported by 2/3rd majority of the total number of Trustees present in person out of which two should be from Founder Trustee.
- 17. Winding Up. The trust may terminate its activities if governing Council recommend & call a meeting of Board of trustees for the purpose by giving atleast twenty one days notice and passing a resolution by atleast 3/4th majority of the total number of trustees present in person.
- 17.1 On its winding up no part of the Trust property shall be distributed among the trustees, donors or their relatives and all the properties of the Trust shall be handed over to a trust society, institution or organization having similar objects or the present Trust may amalgamate with some other trust having similar objects. All the assets and liabilities of the present trust will pass on the successor trust, society, institution or organization. Such trust, society, institution or organization will be decided by the Governing Council.
